Terms and Conditions

- I/We agree to pay weekly in advance. Failure to do so may result in your child's place being suspended, until payment has been received, and will incur a £5 late payment fee.
- I consent for my child to attend Pilgrim Pirates Club. I understand that the after school childcare works under the policies of the school and that there are expectations and obligations relating to both the after school childcare and myself and my child and I should agree to abide by them.
- We reserve the right to withdraw a child's place immediately if a child's behaviour and conduct is deemed to be unsafe or inappropriate.
- You need to understand that the after school childcare is a play care facility and that whilst your child is there Pilgrim Pirates Club is responsible for him/her.
- My child will be in the care of Pilgrim Pirates Club until collected and signed out by a 'Named' responsible adult.
- I will inform the school if I am collecting my child from school or they have not attended school on the day that he/she is booked in to the after school childcare.
- I understand that if I do not inform you, I could be charged for the booking.
- I understand that there will be a charge of £10.00 for any returned cheques to cover bank charges.
- I understand that I am not guaranteed a space if I don't have permanent days booked.
- Pilgrim Pirates Club closes at 5.45pm and if for any unforeseen circumstances you are going to be late, you will need to contact the school to let us know.
- If my child is not collected by the end of his/her booked session, I will pay a charge of £2.50 per every 10 minutes late, to cover the cost of staff that are legally required to stay.
- If any child remains after 6pm, after doing everything possible to contact parents and emergency contacts, then Pilgrim Pirates Club could be legally required to contact the First Response Team (Social Service)
- Whilst we try to ensure that the safety and security of items, we cannot be held responsible for anything lost or stolen.
- Any information and details regarding my child will be treated as confidential. However, there may be times, for example in cases of child protection concerns, when details of my child may be passed on to other agencies. For example police, social care and healthcare professionals.
- Pilgrim Pirates Club will give two weeks' notice to terminate this contract unless the safety and / or welfare of the children, or staff, are not guaranteed where upon the contract will be terminated immediately.
- My child will be provided with a snack and drink whilst at the after school childcare unless otherwise requested.
- My child will be given stimulating and challenging play opportunities in a fun and safe environment.
- If my child has an accident, then he/she will be treated by a qualified first aider and I will be informed of the situation as soon as possible. If there is a situation where my child needs urgent medical treatment and I'm unavailable, a member of staff from Pilgrim Pirates Club may sign consent forms necessary for treatment on my behalf.
